Dear Joey:

As the CEO of The Greenwood Village Chamber of Commerce, I recently had occasion to advocate on behalf of one of our members – Denver Lincoln Limousine regarding a situation that arose at Denver International Airport regarding a summons that was issued regarding PUC and licensing.

Once Andy Poppenberg explained the situation to me, I knew that the situation was handled in a way that was not in actual accordance with regulations. Prior to coming to the Chamber, I retired from Denver PD with over 27 years of service and have extensive background and understanding of the licensing ordinances regarding limousines and taxis.

I arranged a meeting with officials from the Denver Mayor's Office as well as DIA Administration to help shed light on the matter. We discussed the situation and I noted that the City Attorney's Office had dismissed the summons because their review showed that it should not have been issued originally. They went back to their respective departments and made procedural changes based on our conversations.

Since that time, Denver PD and Denver International Airport have also altered their policy based on clarification by PUC regarding licensing tabs and should the same situation arise today, there would be no summons issued.

All of the staff at Denver Lincoln Limousine are properly licensed to operate anywhere in the City of Denver including Denver International Airport as I have personally observed each driver's herdic card.

I would like to provide a personal endorsement of the level of service and trust I have for Denver Lincoln Limousine. I am also the Director of Public Affairs for a large radio station group in Denver.
